Catalog Description:

COE 8163. Spirituality in Counseling. (3) Three hours lecture. Didactic instruction of developmental models and clinical intervention related to the interface of spirituality and counseling.

Goals and Objectives:

The focus of this course is on developing knowledge and practical skills in working with spiritual and religious issues in counseling. At the conclusion of the course, students should:

- 1. Be able to explain how varieties of spiritual phenomena are understood from the perspective of diversity.
- 2. Understand the relationships, including similarities and differences, among various views of spirituality including, religious, spiritual, transpersonal, and psycho-spiritual.
- 3. Know the basic beliefs of various spiritual systems, including the major world religions, indigenous peoples spirituality, agnosticism, and atheism.
- 4. Understand at least two models of human spiritual development across the life span.
- 5. Describe research, theory, and clinical evidence that indicate the relationships between spiritual phenomena on the one hand and mental health on the other.
- 6. Explain how the potential power of combining spiritual issues with counseling methods compels the counselor to operate from a solid ethical base.
- 7. Understand ones own spiritual perspective by identifying key events in ones life that contributed to the development of ones own spiritual perspective and explain how those events contributed.
- 8. Identify specific attitudes, beliefs, and values from ones own spiritual perspective that may support or hinder respect for and valuing of different spiritual perspectives.

- 9. Actively engage in an ongoing process of challenging ones own attitudes and beliefs that hinder respect for and valuing of different spiritual perspectives.
- 10. Conceptualize oneself from two different models of human spiritual development across the life-span.
- 11. Conceptualize oneself in terms of research, theory, and clinical evidence that indicate the relationships between spiritual phenomena and mental health.
- 12. Demonstrate openness to, empathy with, and acceptance of a variety of spiritual phenomena.
- 13. Describe the role of the client's spiritual perspective in an understanding of the client as a whole.
- 14. Acquire knowledge needed to better understand clients' spiritual perspective, by requesting information from the client themself and/or from outside resources.
- 15. Identify when one's understanding and/or acceptance of the client's spiritual perspective is insufficient to adequately serve the client.
- 16. Assess the relevance of the spiritual domain in client's therapeutic issues.
- 17. Use spiritual terms and concepts that are meaningful to the client.
- 18. Use clients' spiritual perspective in the pursuit of their counseling goals as befits their expressed preferences.
- 19. Apply spiritual developmental theory to facilitate client understanding of their present stage/status of life-span spiritual development.
- 20. Be able to share research, theory, and clinical evidence with clients to facilitate their understanding of the relationship between spiritual phenomena and their mental health.
- 21. Demonstrate competent use of techniques for remediation of problems with, facilitation of, enhancement of, and psychological integration of, spiritual phenomena.
- 23. Know when to consult with professionals in the area of spirituality, including those client considers a spiritual authority, when such consultation would enhance service to clients.
- 24. Identify the limits to one's acceptance or competence, seek consultation, seek further education or training, and/or demonstrate appropriate referral skills.

- 1. History of spirituality and religion in counseling (3 hours)
- 2. Developmental models of spirituality and religion (6 hours)
- 3. Spiritual development of counselor and client (3 hours)
- 4. The therapeutic relationship and spirituality (5 hours)
- 5. Techniques and interventions (18 hours)

Assignments:				
1.	Write a spiritual autobiography. Conduct a life review and draw on in-class exercises to identify the significant events (i.e., people, places, and historical events) that have contributed to your current spiritual/religious perspective. Discuss how your current perspective may facilitate and hinder your work as a counselor as well as areas of growth for you. This paper should be approximately 10-12 pages in length. (25 points) DUE			
2.	Attend two religious or spiritual services different from your religious/spiritual tradition. Cross-cultural events/activities are strongly encouraged. You may team up with other class members, however each individual should write his/her own reaction papers (3-5 pages). Your papers should include the following: 1) a description of the activity; 2) rationale for choosing the activity; 3) what you learned about this religious tradition and your own spirituality from engaging in the activity; and 4) implications for counseling derived from this experience. (25 points) DUE			
3.	Participate in a spiritual development practice during this course, keep a journal and write a report of your experiences (5 pages). Examples include participating in yoga practice, regular meditation practice, receiving Reiki or other energy/body work, participating in a breathwork session, learning and practicing centering prayer, meeting with a spiritual director, or attending a structured spiritual retreat. This spiritual practice should be something new for you, not just a report of something you already do. Please obtain prior approval from the instructor before you begin your activity. Your paper should include the following: 1) a description of the activity; 2) rationale for choosing the activity; 3) what you learned/experienced by engaging in the activity; and 4) implications for counseling derived from this experience. (25 points) DUE			
4.	<u>Take home final examination.</u> This comprehensive examination will be a take-home essay case study requiring you to integrate theory, in-class lectures, presentations, discussion, and personal perspectives. (25 points).

The format of the class will include assigned readings, didactic instruction, demonstration of skills by the professor, in-class practice of skills by students, videotape examples of spiritually oriented therapeutic techniques, student presentations, and class discussion.

Suggested topics: spiritual dimensions of addictions recovery; near death experiences; spiritual emergency; goddess worship, Wicca, new age spirituality, cults, women and the church, Buddhism and western psychology, Native American spirituality, drug induced spiritual experiences, fundamentalism, homosexuality and spirituality, etc. (30 points)
